**Full Time Terms and Conditions of the Contract Agreement:**

**1. Payment Policy:**

The learner and sponsor are required to adhere to the payment procedures and policies unless a prior arrangement has been made between the learner, sponsor and school.

- 1.1. The learner and/or sponsor are bound by contract to pay for the learner's school fees by stipulated date.
- 1.2. The Pyramid Spa & Beauty School requires a deposit which must be paid, on or before registration day or as per the application form. The deposit covers the kit cost as well as secures the learner's place in the course. This amount is agreed upon in the signed contract/application form at the beginning of the course or on registration.
- 1.3. The balance of the school fees may be paid in installments. Monthly installments are to be paid in advance by the 1<sup>st</sup> of each month. Failing to do so could result in suspension of the learner until outstanding payment is settled. Lessons missed will not be repeated and it is the learner's responsibility to catch up the work missed on their own.
- 1.4. School fees are inclusive of the following: Kits, learning material, uniform, towels, photo copies and compilation of case studies, Fundamental Textbooks and The Pyramid Beauty School Examinations.
- 1.5. School fees do not include the following: International Examinations and stationery.
- 1.6. Payment can be done via Credit Card, EFT, Cheque, Direct Deposit or Cash.
- 1.7. The learner's full name should be used as a reference.

1.9. Learners shall not be permitted to enter and write the national and international examinations unless the contract price and all other amounts outstanding have been paid in full.

**Cancellation Terms:**

- 1.10. Cancellation: If the learner has paid the deposit, and wishes to cancel the contract before the start date of the course, this must be done in writing a minimum of 30 days before 1<sup>st</sup> day that the course is due to start. The deposit will be refunded.
  - 1.10.1 If the learner has paid a deposit and cancels within 30 days of the start of the course, the deposit will not be refunded.
  - 1.10.2. If the learner wishes to withdraw from the course at any stage after Registration Day (after the course has started) this must be done in writing.
  - 1.10.3. A full term's fees will be charged as a cancellation/withdrawal fee. Any other outstanding monies are also to be paid in full. The cancellation fee must be paid by the specified date as arranged between the school and the sponsor. Failure to do so might lead to further legal action being taken against the learner and/or sponsor.
  - 1.10.4 If a learner's fees are paid up in full for the full time course, and the learner wishes to cancel or withdraw early from the course, this must be done in writing and with a minimum a 30 days' notice. A full term's fees will be charged as cancellation fee/withdrawal fee, and thereafter any balance left may be used as payment towards a part time course for that same year or towards the deposit for the following year's course fees.
- 1.11. The Pyramid Spa & Beauty School reserves the right to change course syllabus, lecture times and learner fees as well as admission policies.
- 1.12. Certification and final results will not be issued until the course has been completed and full payment has been settled.
- 1.13. Whilst every care has been taken to ensure the wellbeing and care of your person and personal belongings, the learner will still remain responsible their own personal safety and that of their personal belongings. The Pyramid Spa & Beauty School is not responsible for any damage, theft, loss or misfortune that may occur, whilst attending lectures at The Pyramid Spa & Beauty School, or whilst out on an outing, whilst on assignment or for any other reason whatsoever.
