Full Time Terms and Conditions of the Contract Agreement:

1. The learner and sponsor are required to adhere to the payment procedures and policies unless a prior arrangement has been made between the Learner/Sponsor and The Pyramid Beauty School.
2. Payment must be made by the **FIRST day of every month**. Failing to do so could result in suspension of the learner until outstanding payment is settled.
3. Payment can be done via Credit Card, EFT or Cash payment.
4. School fees are inclusive of the following: Kits, learning material, uniform, towels, photo copies and compilation of case studies, Fundamental Textbooks and The Pyramid Beauty School Examinations and one ITEC International Qualification Examination fee.
5. School fees do not include the following: Any extra International Examinations (optional) and stationery.
6. The Pyramid Beauty School reserves the right to change course syllabus, lecture times and learner fees as well as admission policies. Certification and final results will not be issued until the course has been completed and full payment has been made.
7. No variation, alteration or consensual cancellation additional to the contract shall be binding upon the learner and The Pyramid Beauty School, unless reduced to writing and signed by both the learner and The Pyramid Beauty School.
8. Learners shall not be permitted to enter and write the national and international examinations unless the contract price and all other amounts outstanding have been paid in full.

Full Time Cancellation Terms and Conditions of the Contract Agreement:

1. If the learner has paid the Registration Fee, and wishes to cancel the contract before the start date of the course, this must be done in writing a minimum of 10 days before 1st day that the course is due to start. The deposit will be refunded.
2. If the learner has paid a deposit and cancels within 10 days of the start of the course, the deposit will not be refunded.
3. If the learner wishes to withdraw from the course at any stage after Registration Day (after the course has started) this must be done in writing. A full term's fees will be charged as a cancellation/withdrawal fee. Any other outstanding monies are also to be paid in full. The cancellation fee must be paid by the specified date as arranged between the school and the sponsor. Failure to do so might lead to further legal action being taken against the learner and/or sponsor.
4. If a learner's fees are paid up in full for the full time course, and the learner wishes to cancel or withdraw early from the course, this must be done in writing and with a minimum a 30 days' notice. A full term's fees will be charged as cancellation fee/withdrawal fee, and thereafter any balance left may be used as payment towards a part time course for that same year or towards the deposit for the following year's course fees.
